Directors' Report

To the members,

Your Directors submit this report, together with the audited accounts of the Co-operative for the year ending 30 June, 1996.

The Directors in office at the date of this report are:-

Chairperson - Gayle Stagnitta

This will be my last report to you as Chairperson and it is time for members to elect a new Board of Directors. I do ask you to think carefully about the people you vote for as it is very hard work and needs people with a real commitment to work, on behalf of all members and low-income people, the people on the Board need to be very honest and not there for power.

We, the Board of Directors, have had the sad job of having to remove one Board member at the last Board meeting, Ms Helen Rosa. If you elect any member with an overpowering personality that demand his or her own way over the majority, it is very hard for the Board to work on your behalf. So I ask again, think carefully about who you elect.

Special thanks to Debbie Page for all the hard work she has put in this year. Margaret Bartlett has also worked hard on your behalf. When I look back on this year, it has been a tough year for all members of the Board and Workers. I will give you an idea of some of the things we have had to deal with, some very unpleasant things indeed !

The previous Co-ordinator did not keep accurate financial records, he spent money without informing the Board, he lied to the Board, he would not give us information we needed to make informed decisions on your behalf. When he left ARC was in a real mess. There was no accountability at all, no decent records were kept in areas such as the Emergency Aid accounts. The previous workers acted against the interest of the members of ARC.

Emergency Aid is now fully recorded. ARC's money is now being organised through the Credit Co-op which means there cannot be any misuse of funds and the savings and loans component at ARC does not exist any more.

All these changes mean ARC is fully accountable to its members, probably for the first time. The workers we have now have supported and implemented all these changes as have the remaining Board members. There are only 4 of us left myself, Debbie Page, Margaret Bartlett and Carmen Walsh. Most of the difficult things have been dealt with this year. I believe we have now moved past these difficult problems and ARC now has a future to look forward to.

A new worker is going to be employed soon which means that it will free the other workers up to do their own jobs. Probably this has been a hard time for them too. I believe they will be glad things are settling down and they can concentrate on moving ARC forward. The Brotherhood would like to see us succeed.

I think our Board need to have some outside people on it and the Brotherhood are interested in having some representation. I believe this would be a move forward for us as we need all the help we can get. Things are getting real tough for low-income people. If we all pull together ARC can make it a bit easier for some of these people.

As you will notice there is no Co-ordinator report this year, as Jill Meade was not appointed as Co-ordinator until the Financial year was nearly over. I do believe she will get ARC going in the right direction this year if given the help and support of everyone involved with ARC. Thanks to Jill, Ian and Alexia for hanging in there !

This report is a true account of the year gone by. I think you members out there need to know there have been a lot of problems in the last year. I will finish by wishing the new Board the best of luck and if there is any way in which I can help out I will.

Boy ! What a year it has been. There has been a big change over in staff for one. There's been major changes in the Savings and Loans component at ARC.

I hope that at the A.G.M. the members think and choose their Board of Directors very wisely because they are there to represent you, the member. Gayle has been a wonderful support person for me on the Board. Thanks Gayle you have been my teacher. ARC is loosing a highly committed Chairperson. I thank all the Board members this year for their work. It was a hard year for everyone. Remember that workers are there to help you. They are a voice for low-income people. Thanks to Jill, Alexia and Ian for all the effort they have put into ARC. I welcome Jude to the ARC team.


Director - Margaret Bartlett



DIRECTORS' REPORT

In accordance with resolution of the Directors, the Directors submit herewith the Balance Sheet at 30th June, 1996 and the Profit and Loss Statement for the year ended on that date and report as follows:

(a) The names of the Directors in office at that date of this report are as follows:

- (b) The principal activities of the Society are as follows: to provide community services, benefits and support to members.
- (c) The operating loss of the Society for the year amounted to \$(24) and no provision for income tax was made.
- (d) No share issues were made during the year.
- (e) No transfer to Statutory Reserve has been made during the year.
- (f) In accordance with the Rules of the Society no dividend was paid or credited during the year.
- (g) The Directors, before the profit and loss account and balance sheet were made out, took reasonable steps to ascertain what action had been taken in relation to the writing off of bad debts and the making of provision for doubtful debts, and to cause all known bad debts to be written off and adequate provision to be made for doubtful debts.
- (h) At the date of the report, the Directors are not aware of any circumstances that would render the amount written off for bad debts or the amount of the provision for doubtful debts inadequate to any substantial extent.
- (i) The Directors, before the profit and loss account and balance sheet were made out, took reasonable steps to ascertain whether any current assets are unlikely to realize in the ordinary course of business their value as shown in the accounting records of the Society and if so, to cause -
 - (i) those assets to be written down to an amount that might be expected so to realize; or
 - (ii) adequate provision to be made for the difference between the amount of the value as so shown and the amount that they might be expected to realize;

(j) At the date of the report, the Directors are not aware of any circumstances that would render the values attributed to current assets in the account misleading.

No contingent or other liability has become enforceable or is likely to become enforceable within a period of twelve months after the end of the financial year which, in the opinion of the Directors, will or may affect the ability of the Society to meet its obligations as and when they fall due.

- (k) At the end of this report, the Directors are not aware of any circumstances not otherwise dealt with in the report or accounts which would render any amount stated in the account misleading.
- (I) The results of the Society's operations during the financial year were not, in the opinion of the Directors, substantially affected by any item, transaction or event of a material and unusual nature.
- (m) There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the Directors, to affect substantially the results of the Society's operations for the next succeeding financial year.

No Director has, since the end of the previous year, received or become entitled to receive a benefit (other than a benefit included in the aggregate amount of the emoluments received or due and receivable by the Directors, shown in the amounts or the fixed salary of a full-time employee of the Society) by reason of a contract made by the Company with the Director or with a firm of which he is a member, or with a company in which he has a substantial financial interest.

1. <u>SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES</u>

The accounts are prepared in accordance with the historical cost convention. The accounting policies adopted are consistent with those of the previous year.

(a) <u>Depreciation</u>

Depreciation is calculated on a straight line basis so as to write off the net cost of each fixed asset during its expected useful life.

(b) Grants Received

Grants received have been allocated proportionally over the period covered by the grants, and brought to account as income accordingly.

(c) Income Tax

The Society has been granted Income Tax exemption.
